The Wabash County Health Department Authority shall be contacted: **before any work begins and when construction, installation, modification or repair of onsite sewage disposal system is complete and ready for inspection.** The Wabash County Health Department Authority shall endeavor to inspect all systems **within two (2) business days** after notification. According to the Wabash County Sewage Ordinance: "Any person who violates a provision of this ordinance shall be guilty of a misdemeanor and upon conviction thereof may be fined not more than two thousand dollars (\$2,000). Each day during or on which a violation occurs or continues shall be deemed a separate offense."
