A recent review of the Agreed Order, adopted on February 19, 2018 has indicated that Carriage House Estates, LLC (Respondent) is in non-compliance with the Agreed Order, as follows:

1. Order Paragraph 4, Within 60 days of the Effective date, Respondent shall submit the missing DMRs and MROs from April through December 2017.

Respondent has not submitted the missing DMRs and MROs. In addition, Respondent has failed to submit DMRs and MROs for January to June 2018. Please note that while you maintain a NPDES Permit, even though your system no longer has a discharge, that a DMR and MRO is still required with the notation that "No discharge occurred" indicated on the report.

Order Paragraph 9 assigned a stipulated penalty for failure to submit missing DMRs/MROs within thirty days of the Effective Date. The assigned stipulated penalty is \$500 per week late or part thereof. At this time, IDEM is not assessing a stipulated penalty for failure to submit the DMRs and MROs.

An IDEM inspection conducted on May 7, 2018, found your system satisfactory at the time of the inspection. However, during a conversation with the inspector he mentioned that the pond is nearing capacity. As a reminder, the Indiana State Department of Health established a two (2) year limit on the length of time that a mobile

home park can pump and haul (see 410 Indiana Administrative Code 6-10.1-49(e)(3)). In the interim, please monitor this on a routine basis to ensure an overflow does not occur. In addition, thank you for your monthly installments towards the civil penalty.
