Re: Request for 30-Day Extension of  
Generator's Hazardous Waste Accumulation Time  
- Laketon Refining Corporation -  
EPA I.D. # IND005452933  
Laketon, Wabash County

On November 8, 2018, the IDEM Office of Land Quality received a letter requesting a 30-day extension for hazardous waste accumulation time, for two drums of "groundwater recovered oil containing PCBs" with accumulation start dates of August 13, 2018 and August 23, 2018. The waste in question is located at 2784 West Lukens Lake Road, Laketon, Indiana.

Based on the information you have provided, although the waste is regulated by the used oil portion of the Subtitle C regulations, the waste is not hazardous. Therefore, an extension cannot be granted pursuant to 40 CFR 262.34(b) as referenced by 329 IAC 3.1. With that said, this waste stream appears to be PCB impacted used oils with concentrations making it regulated by the state and federal PCB rules, found at 40 CFR 761 and 329 IAC 4.1.

IDEM:

As specified at 40 CFR 262.34(f) and incorporated by reference at 329 IAC 3.1-7-1, the purpose of this letter is to request an additional 30 days for accumulation of hazardous waste at our facility in Laketon, Indiana. Additional time is requested because the designated TSDF, Veolia ES in Port Arthur, Texas, went down for a maintenance turnaround and was unable to take our drums of groundwater recovered oil containing PCBs and other hazardous constituents that was scheduled for the September 20, 2018.

It was anticipated that they would be able to take them in October but that did not happen. They are now scheduled for pick-up at Laketon on November 19, 2018 but that will be past the 90-day accumulation limit for two drums (one filled August 13, 2018 and one filled August 21, 2018) of the 12 that we have ready for shipment. I am attaching a chain of emails between us and our account coordinator, Heritage Environmental Services, to document the events leading up to the rescheduling of our shipment.

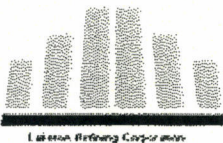
